American Occupational Health Conference (AOHC) 2018

The **Underserved Occupational Populations Section of ACOEM** is sponsoring one \$1,000 scholarship to qualified residents and medical students interested in making significant contributions to the field of underserved occupational medicine.

The scholarship was established in honor of **Joseph A. Fortuna, MD, FACOEM** who founded the Underserved Occupational Populations Section of ACOEM and who was a tireless supporter of underserved workers and their families.

The award is designed to provide financial support to attend AOHC, the largest occupational medicine conference, thereby expanding the awardee's educational opportunities in underserved and general occupational medicine. The selected applicant will then present their research abstract or proposal at the Underserved Section's Annual Meeting at the AOHC.

Requirements:

- Medical or Osteopathic student or Occupational Medicine Resident or Preventive Medicine Resident in good standing
- Submitted research abstract for AOHC 2018 or
- 500 word essay describing active involvement in underserved occupational medical activities with verification from faculty advisor
- International students and residents are welcome to apply

The **Underserved Occupational Populations Section of ACOEM** will provide one stipend of \$1,000 to assist with expenses such as registration fees, transportation, and lodging to attend AOHC, and to be used for ACOEM membership dues if not already a member.
